I have observed most grades and subjects during the academic year. However, depending on the situation, sometimes I spent 5 minutes observing and other times 45 minutes. The school uses IB (International Baccalaureate) as the framework of EIS which is similar to the Danish system except that the curriculum is taught trans-disciplinarily which means it can be a bit difficult for me to separate the lessons into subjects, but I have done my best to do so.

I have visited the school twice during this academic year and have each time been met with openminded students, leaders, teachers, and other staff. In advance of my visit I have suggested possible dates to Jason Lusby and have always been told that I am welcome.

In addition, I follow the school on Facebook and have the impression that adequate measures to handle the Corona-situation have been taken by implementing distance learning. Corona occurred after my last visit.

On 8 September 2019 and 17 February 2020 I inspected EIS and had subsequent conversations with Jason Lusby.

English is the spoken (and approved) language at the school except in language lessons. However, all teachers speak a certain level of Danish and some of them are Danes.

When new pupils start, the teachers provide explanatory translations to help them understand and speak the language but quickly all pupils can speak English. However, as in all cultures, pupils of the same nationality sometimes group together and speak in their native tongue.

Danish students have their own Danish lessons, and the level is on par with that in the Danish state schools. Foreign students who may only reside in Denmark temporarily are hesitant to learn Danish although they are taught so in an adequate way.

Through play, exploration, curiosity, students' outputs, and presentations the students learn knowledge that is relevant to their level and subject. The school benefits from a music room of a high standard. When I was there the students were preparing creepy sounds to be part of a horror movie.

In PE I observed a project for the whole MYP (Middle year programme) where the focus was "thinkers" and "February". The students had to solve some problems about great thinkers from February, and part of the task was a physical exercise.

As previously mentioned, the language spoken is English but most Danish students attend regular Danish classes taught by Danes as in the Danish state schools. The level is high, and the first students have been accepted into the Danish high schools and other school systems. Students with Danish as a second or third language attend Danish classes of a high standard, but most students are not really interested unless they are planning to stay in Denmark.

In English literature the students learn how to analyse relevant literature from different genres, time periods and authors. The level is adequate and similar to that in the Danish state schools.

Through play, exploration, curiosity, students outputs and presentations, the students learn knowledge relevant to their level and subject. I have heard presentations of a high standard and seen test results to confirm my opinion. The student-to-teacher ratio is low, and the materials are interesting and varied.

For each year group and subject the school has an overall plan incorporating trans-disciplinary projects where mathematics is involved in a way that still ensures relevant knowledge is acquired. It was obvious to me that students were familiar with the scientific terminologies in both English and Danish, and the level of participation and engagement was excellent. Whenever possible the students are asked to produce work in compliance with set guidelines. In math's classes the students were solving problems using equations. They explained how they had come up with their answers.

When interviewed the students all expressed their great appreciation of the teachers and the school facilities. The teachers cooperate and work closely in order to improve the students' learning environment.

Obviously, the level of English is higher than in Danish state schools due to the lessons being taught in English. In English classes a wide variety of authors, literary periods, and genres are being taught – often as part of a multi-disciplinary project.

Also, I noticed a great focus on diverse use of vocabulary and correct spelling. Every day the students have new words to spell. Part of it is taught through conventional methods but quizzes, games and plays are also applied.

One example is that the school focuses on UN conventions. This can be seen on posters and through topics that the students work on, but most importantly I felt the open-minded and yet polite atmosphere among staff and students which gives me a sense that there is democracy and freedom throughout the school.
